Why is Strategy execution difficult?


Top 3 issues impacting success:

5 Keys to Successful Strategy Execution



COMMIT TO A STRATEGIC PLAN

Before diving into execution, it's important to ensure all decision-makers and stakeholders agree on the strategic plan.



ALIGN JOBS TO STRATEGY

COMMUNICATE WITH EMPLOYEES

Strategy execution depends on employees' daily tasks, so it's vital that they understand the organization's strategic goals.



MEASURE AND MONITOR PERFORMANCE

Strategy execution relies on assessing progress toward numeric goals.
If metrics are down, reassess and pivot your strategy.



BALANCE INNOVATION AND CONTROL

While innovation is a driving force for company growth, don't let it derail your strategy execution.

- 2. Portfolio Management (resource allocation)

Tools

Program Management is...

... a framework for implementing business strategies, policies and initiatives, or large-scale change.

It provides a framework that integrates and reconciles competing demands for resources, and provides a focus for projects.








Top Down, then Bottom Up ...





Innovation and Sustainability at BHP

Amplify is supporting global innovation teams to find the critical resources necessary to drive the energy transition




© THE CHALLENGE

BHP have aggressive operational, financial and environmental goals baked into their strategic plan.

They needed a way to performance metrics against targets across their global innovation portfolio.

With multiple innovation teams and subsidiaries BHP had difficulty tracking how innovation projects and programs were contributing to enterprise strategic goals.



- Providing decision makers with access to real-time performance data.
- Executives can see progress against targets and updated forecasts.
- Can now take corrective action much sooner when lead indicators trend down.

CASE STUDY

Supply Chain Optimization at Pfizer

Amplify is supporting Pfizer to get their products to market at "Lightspeed"



- Pfizer's Global Supply Chain includes 30,000 staff and 40+ manufacturing sites globally
- Ramping up to full production once a new product is approved was taking up to 18 months
- Covid-19 vaccines required a novel approach



- Amplify provided executives with realtime visibility into the effect of change on manufacturing cycle times
- Cross-functional visibility of program risks help adapt to change with reduced disruption and cost.

Strategies for improving Program Management

- Encourage and foster collaboration and cross-functional teamwork led by the SEO, TMO etc.
- Invest in training and development for all program stakeholders so they understand and can perform their role
- Leverage technology and tools to support accountability, governance and transparency
